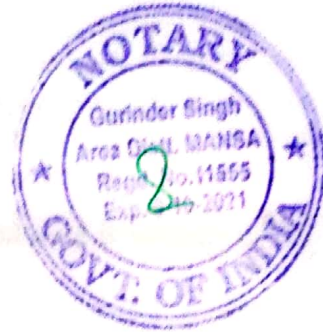

In regard to above subject

2. After watching carefully the documents along with affidavit submitted by the management of school, recommendations of District Education Officer (Sen. Sec.) and Director Education department (Sen. Sec.) Punjab, Chandigarh, the required No Objection certificate has been issued by the Government of Punjab on following conditions:-

1. in future if on inspection of any complaint the fact found that you have submitted application on false information at the time of obtaining No Objection certificate and or the rules of Government of Punjab issued time to time are not followed and the conditions mentioned in the affidavit are not comply with, then in these circumstances, this No Objection certificate can be withdrawn.

2. in your School Punjabi will be compulsory to study up to Tenth and CBSE New Delhi will compulsorily tried to take test of Punjabi in these schools and along with this it is also stated that in case of not doing so, the No Objection Certificate will be withdrawn.

3. School Management will obey as it is the Notifications issued under RTI Act 2009 by Education Department Government of Punjab and Rules of RTI Act 2009 enacted for Punjab State.

4. After obtaining affiliation of CBSE New Delhi, the School Management will be committed to pay salary and other allowances etc. to teaching staff and non teaching staff similar as Govt. Employees through Account Payee Cheques. In case of not doing so, the No Objection Certificate will be withdrawn.

5. You yourself and your management also committed that when any information has been demanded by your District Education officer or any senior officer of education department, then the necessary information will be provided and also required support will be given.

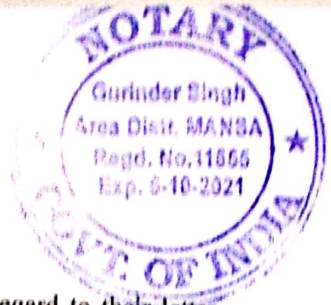
