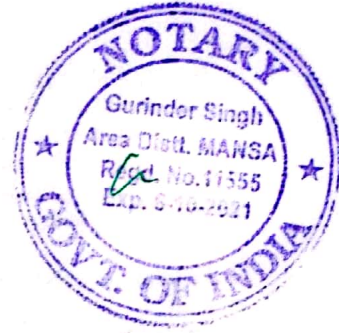

Sub:- Acceptance of affiliation letter of school for providing free and compulsory education to children as per Rule 15(4) compliance of Section 18 of Right to Free and Compulsory Education of children act, 2009.

Sir/Madam

As per your requests and after correspondence with the school in this regard/subject to inspection, affiliation has been granted to Atma Ram Memorial Convent School, Bareta District Mansa form class First to Eighth. The said affiliation has been granted as per following conditions:-

1. The affiliation has not been expendable and it is not to be perceived in any condition that this is compulsory for affiliation to higher affiliation from 8th class.
2. School will follow the rules relating to (Section I) of right to free and compulsory education of children act, 2009 and (Section-II) of right to Free and Compulsory Education Rules 2010.
3. School in First Class(or in former class, whichever is applied), 25% of weaker sanction and children of surrounding group of un-facilitated area out of total strength will admit and will provide free and compulsory primary education till its completion.
4. As per rules of section 12(2) of the Act the expenses of children as mentioned in Para No.3 will be provided to school. School have to maintain separate bank account for its fulfilment.
5. School/Organization will not take any capitation Fees and will not adopt any provision regarding election of children or their parents or guardian.
6. School will not refuse to admit any child in absence of birth proof and will obey Section 15 of the Act.
7. School will also assure that:-
 - (a) Any child admitted in school will not be kept again in school or will not be removed from school until his primary education will not be completed.
 - (b) No child will be punished physically or harassed mentally.
 - (c) There will be no need to pass examination of board to any children until completion of primary education.
 - (d) Character certificate will be issued to every child who complete primary education as per Rule 25.
 - (e) As per Rules of Act special Needs/involvement of physically handicapped students.
 - (f) It is compulsory for teachers that they will complete minimum educational qualifications as per Section 23(1). But there is condition that the existing teachers who have not completed minimum education qualification at the time of implementation of this Act, shall complete their minimum educational qualifications within five years. Statement of teaching and non-teaching staff will be attached.
 - (g) The teachers shall fulfil responsibilities as per section 24(1) of the Act.
 - (h) The teachers shall not make busy themselves in private tuitions.
8. School will obey the syllabus of subjects of study as specified by higher authority.
9. School will obey terms and conditions as specified under Section 19 of the Act. The facilities reported at the time of last inspection are as follows:-

 13. School is not running for benefit of personal, group or group of persons or any other person.
 14. Account will be audited by authorised chartered accountant and statement of accounts will be prepared as per rules. One copy of every statement of account will be sent to District Education Officer every year.
 15. The affiliation code of your school is MNS-045. It will be noted and will be written on letters sent to this office.
 16. School will provide information as demanded by District Education officer time to time and will obey the conditions which will be directed by concerned authority or District Education Officer in regard to fulfil the conditions of affiliation or to remove shortcoming of work of school.
 17. Renewal of registration, if any necessary, be assured to done.
 18. Certificate regarding fire safety and certificate regarding building safety. After expiry of time, again immediately after getting issue again be submitted to this office, in case of not doing so, cancellation of affiliation will be started.
 19. Certificate of Medium and Language.
 20. Copy of A-role of salary of teachers and copy of Mutation of land.

 22. List regarding collection of funds from the students and salary of staff at Govt. Rates.
 23. List of management committee.
 24. Six months salary of staff working for first to eighth class has to be pledged.
 25. If violation of RTI Act and rules has conducted in future then necessary action will be taken as per RTI Act and rules.

Note:- Deficiencies of above stated Serial No ___ will be completed within three months, in case of non completion of deficiencies affiliation will be perceived as cancel.
